

# Budapest Extension - Reservation Form - Starting on Sept 8 or 9, 2012

**Payments:** A \$100 per person deposit to reserve your space on the Budapest extension. Balance is due by May 1, 2012.

**We prefer checks to:** Deposit by credit card payments are via google checkout. We prefer checks for your final payment

**Per Person Double occupancy:** \$189 for 1 night  
\$289 for 2 nights

**Extension includes:** 1 or 2 nights at K + K hotel with breakfast, transportation between Budapest airport and the hotel and from the hotel to ship in Budapest. Transfers are based on two more people.

**Budapest Refunds:** If you cancel before May 1, 2012, you will be issued a refund less \$50 per person for this extension. Cancel from May 1 until July 1, 2012 and you will be issued a refund less \$100 per person for the Budapest extension. Thereafter, the total extension price is non-refundable. For any changes to your length of stay after June 1 there is a \$50 per person charge. Refund and travel protection is not included, but suggested and available by call 800-369-3693. Written cancellation is required and is effective when received by Dream Maker Vacations during normal business hours.

**Note:** Valid U.S. passport is required with six months validity remaining past your return date. For non-U.S. passport holders, you are responsible for finding the entry requirements for all countries you will be visiting or transiting.
