

# Prague Extension - Reservation Form - Starting on Sept 17, 2012

**Payments:** A \$100 per person deposit to reserve your space on the Prague extension. Balance is due by May 1, 2012.

**We prefer checks to:** Deposit by credit card payments are via google checkout. We prefer checks for your final payment

**Per Person Double occupancy:** Deluxe Room: \$498 for 2 nights and \$599 for 3 nights - queen or two twins  
Superior Deluxe: \$540 for 2 nights and \$650 for 3 nights - King bed

**Extension includes:** 2 or 3 nights at Maximilian hotel with breakfast, tours of Prague and Nuremberg and transportation between ship and Prague. Superior rooms features include a larger room, **king bed** & a sofa, and an espresso machine.

**Prague Refunds:** If you cancel before May 1, 2012, you will be issued a refund less \$50 per person for this extension. Cancel from May 1 until June 1, 2012 and you will be issued a refund less \$100 per person for the Prague extension. Thereafter, the total extension price is non-refundable. For any changes to your length of stay after June 1 there is a \$100 per person charge. Refund and travel protection is not included, but suggested and available by call 800-369-3693. Written cancellation is required and is effective when received by Dream Maker Vacations during normal business hours.

**Note:** Valid U.S. passport is required with six months validity remaining past your return date.
