

## Reservation From - Danube or Rhine River Cruise

Before you make your deposit please be sure you have reviewed all of the information on the website. By making your deposit you acknowledge you have reviewed and agree to the terms & conditions here and on this website.

**Payments:** A \$400 per person deposit will be needed now in order to hold your space on the trip. Your final payment is due on May 1, 2012.

**Rate and payment, *We prefer checks to:*** Dream Maker Vacations. Otherwise, credit card payments are via google checkout on website. See website for details.

**Refunds:** If you cancel before 120 days for any reason, you will be issued a full refund less \$350 per person. Cancellations from 120-90 days and you will be issued a refund less 25% of the total trip price. Cancellations from 89-30 days will receive less a 75% charge of the total trip price. Thereafter, there is a 100% charge of the total cruise cost. Refund and travel protection is not included, but suggested and available by call 800-369-3693. Written cancellation is required and is effective when received by Dream Maker Vacations during normal business hours which is defined as 9 am to 4 pm weekdays except for national holidays. Cancellation charges also apply for upgrades, and other pre-purchased services. Hotel cancellation fees will be advised to you when you book those services. Airfares are non-refundable.

**Note:** Valid passport is required with six months validity remaining past your return date. For non-U.S. passport holders, you are responsible for finding the entry requirements for all countries you will be visiting or transiting. Tips to guides and ship staff plus personal items are not included. Order of events, ports, taxes, fees (currently \$125-130 per person) and charges are subject to change. Dates listed above are the cruise dates and you will need to depart North America by one day prior to your first accommodation. Limited cabins are available on each deck and at the listed price.
